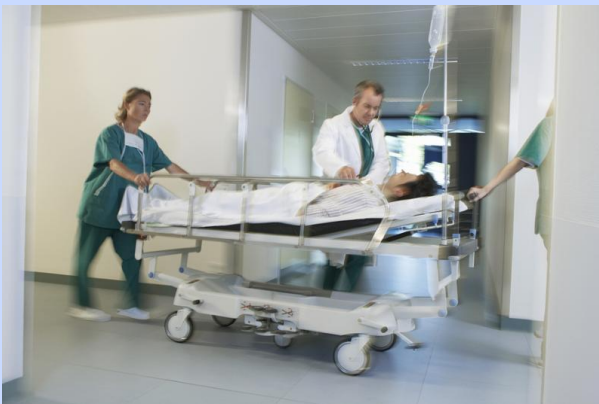

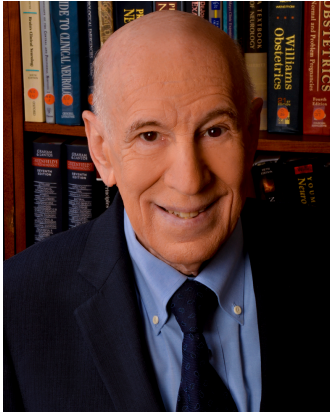


Being a Better Patient Advocate for a Loved One

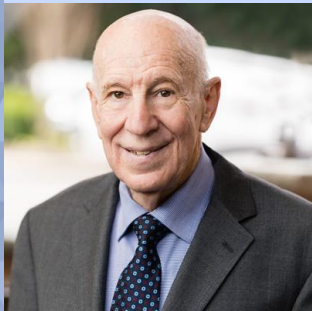

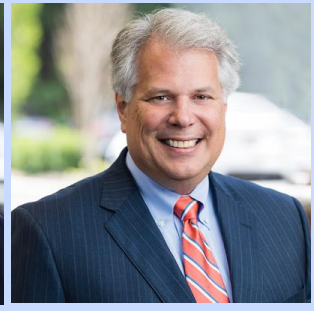

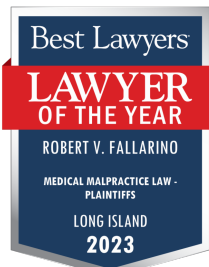
