
What to Expect During Newborn Screening

Blood in the urine, in a man, is cancer until proven otherwise.

This doctor found a lemon-sized cancerous tumor. This client's kidney was completely blocked and he needed to undergo surgery as soon as possible. The left kidney and ureter were surgically removed, and the patient received chemotherapy for his cancer. Due to the delay in the diagnosis, however, the patient's chances for a recurrence of his cancer are greatly increased.

Our experienced team, in consultation with experts in urology, oncology and radiology, were able to show that – had the defendant doctors provided the standard level of care by timely ordering or performing the retrograde pyelogram – the patient's cancer would have been diagnosed and treated years earlier and his opportunity for cancer-free survival greatly improved.
